

## BODY ART FACT SHEET: PERMANENT MAKEUP MACHINES

The State Rule (410 IAC 1-5-34) states that "Any reusable contaminated equipment that comes into direct contact, or is likely to come into direct contact, with an instrument that penetrates the skin other than a piercing gun shall be effectively cleaned and sterilized prior to use."

The Indiana Department of Health interprets the "instrument that penetrates the skin" to mean the <u>entire</u> <u>cartridge</u>. Therefore, the grip or piece that holds the cartridge must also be sterile (either presterilized/single-use or sterilized in an autoclave). If this piece cannot be sterilized, or the machine is onepiece, then it cannot be used.

## BODY ART FACT SHEET: TATTOO PENS

The State Rule (410 IAC 1-5-34) states that "Any reusable contaminated equipment that comes into direct contact, or is likely to come into direct contact, with an instrument that penetrates the skin other than a piercing gun shall be effectively cleaned and sterilized prior to use."

The Indiana Department of Health interprets the "instrument that penetrates the skin" to mean the <u>entire</u> <u>cartridge</u>. Therefore, the grip or piece that holds the cartridge must also be sterile (either presterilized/single-use or sterilized in an autoclave). If this piece cannot be sterilized, or the machine is onepiece, then it cannot be used. Coil and other rotary machines that use cartridges must also be used with sterile grips.

Below are some examples of acceptable tattoo pens that can be used with pre-sterilized, disposable grips.

Other pens have grips that can be removed and autoclaved. If using one of these machines, be sure to have a supply of sterilized grips in peel packs.
